<http://www.holyshroud.info>. I told a number of officials in the Archdiocese of New York about my
 talk in 2011 with the expectation of getting support and direction. Instead, I was given a runaround.

Acting on the advice of Fr. Daniel Gatti, Alumni Chaplain of Fordham, I contacted churches directly. I
 was invited to give a talk at a church in Harlem on March 30. When I arrived with my projector, the

 opinion, he is also deceiving himself about the history the Holy Shroud, which is part of our
 salvation history.

I filed a complaint against this pastor and the officials with Bishop Dennis Sullivan, the Vicar
 General. Bishop Sullivan's response to my complaint and my subsequent correspondence is
 blameworthy in a number of different ways, so it seems to me. He is in effect supporting the
 actions of the pastor.
